Partnerships are in place with Frankfort Emergency Response personnel and safety plans are developed and revised as necessary and shared with appropriate community partners. School and Diocese is looking into obtaining School Resource Officer in addition to measures already in place.

Open discussion was held with parents and those in attendance. Attendee questions were addressed with additional meeting to be held in the future.
