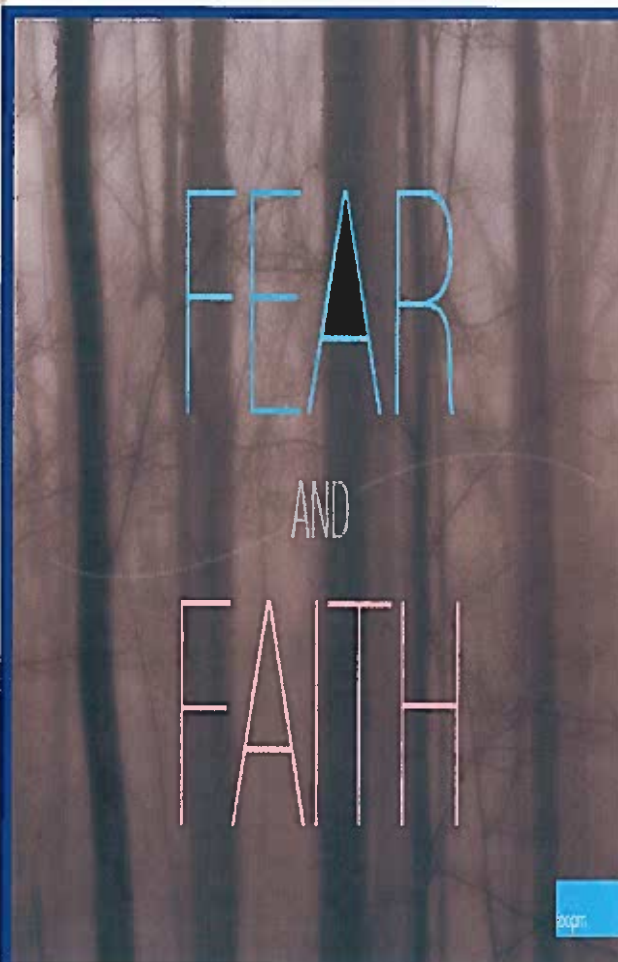

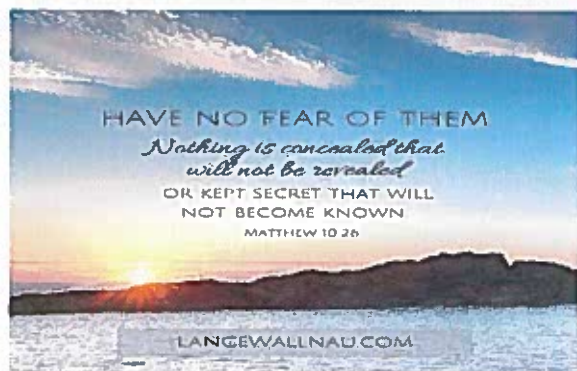
**PARISH NEWS****Locked Drop Boxes**

**If you are experiencing any of the following, please stay home or return home and take care of yourself:**

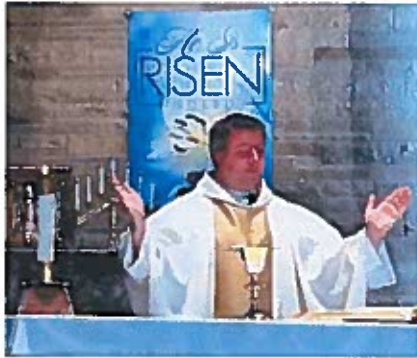
- Cough
