- **Financial Information:** All crafters ***must*** submit a completed MN **Form ST19-** Operator Certificate of Compliance. This is required by the state of Minnesota. A blank form and more information about the form is attached to this application.
- Crafters must remain set up until 5 pm on Saturday to avoid traffic congestion with persons arriving for the 5 pm Mass.
- **Items must be handcrafted.** Only the St. Vincent's Council of Catholic Women may offer raffles and food items for sale.
- If you would like to donate a craft item to our raffle, please contact Candy Alstadt at [calstadt@yahoo.com](mailto:calstadt@yahoo.com).
- **Space specifications - all spaces are approximate.** We are a church and school first and therefore are doing our best within the limitations of our physical building to accommodate the space sizes offered to you. Please plan accordingly if you need to modify your set-up within our set guidelines for your booth. The booth size we provide you will be the limits by which you must abide. No merchandise may be placed outside the marked edges of your space.
- All accepted applications for spaces will be confirmed by email on or before Sept 30, 2025.
- A Wi-Fi password will be provided onsite for crafters accepting credit card payments.
- Tables must be skirted or draped.
- Exhibitors must clean up around their areas at the close of the crafter portion of the bazaar on Saturday at 5 pm.
- St. Vincent de Paul Church or St Vincent de Paul CCW is not responsible for injury, theft or damage.
- All our buildings are smoke-free.
