**St. Michael's ATM Meeting Minutes**  
**Tuesday, January 13, 2026**

Below is a summary of the Agenda items that were discussed during the meeting held in-person at the Lake House Library. Thank you to all who were able to join us.

**Opening Prayer:**

- Members joined in the ATM opening prayer.

**November 11, 2025, Meeting Minutes:**

- Will Langley made a motion to approve. Mark Law seconded. Unanimously approved.

**Budget/Finance Report:**

- Kathy reviewed/shared:
  - November Report
    - Robert said he saw that funds were sent to Tazewell Ministerial Association and asked if we have received financial information from them. Paul advised that we did request this from Pastor Grills and Thresa, who handles their funds. No report has been received yet. Paul and Kathy will follow up.
  - Christmas Programs Donation
    - Received anonymous donation of \$2,036 and specified it to be used for Christmas programs in Southwest Virginia. Paul & Kathy sent emails to both Fr. Renier and Kim Shoun for input.
      - Fr. Renier advised that Mary's, St. Joseph's, and St. Theresa's have Christmas programs. A check for \$1,036 was sent to Holy Family Parish to help support these. (email passed around in correspondence folder)
      - Kimberly Shoun, Center for Christian Action Director, advised that they have a Christmas gift card program where they give \$100 gift card to families to help them purchase food for their Christmas meal. A check for \$1,000 was sent to support ten families for this program. (email passed around in correspondence folder)
  - Teen Venture Financial Report
    - Mark received report which was passed around to the members. Paul noted that it did not include current year assets and liabilities so he asked Mark to contact the Director and ask for this information as well as the most current 990 Tax Form.

**Holy Family Parish (HFP) Coordination:**

- Updates from Ralph Shawver
  - Fr. Jay Biber covering all Masses until Fr. Renier returns on January 21.
  - Nine new members are preparing to join Holy Family Parish during the Easter Vigil. They are from all four church locations and are mostly current residents.
  - St. Mary's has received donations of about \$13,000 toward the estimated \$30,000 needed. #iGiveCatholic has been open for donations for about one month. The Diocese has recommended that the same group who refurbished the murals at St. Elizabeth's be used to repair the windows. It is Holy Family Parish's decision on who to use.
  - There are no plans yet for a Spring picnic.

- “Giving Tree”
  - Total gift cards and cash received was \$1,715. This does not include online donations that continued through December 31. Will said that he is planning to go down to Tazewell in February, so he will deliver these.

#### **Center for Christian Action (CCA):**

- Kathy shared email from Kim
  - Had 46 Angels adopted by individuals for their Angel Tree program.
  - Have forty-two families signed up for the Christmas Gift Card program which will cost \$4,200. They have received \$2,000 towards this program.
  - Had an emergency request for a family with two children to provide gifts because the dad was hurt at work and had not received his pay due to a mix up in paperwork.

#### **Teen Venture (TV):**

- Mark had nothing new to report other than receiving their financial information.

#### **Liaisons’ Reports:**

- Dona – Nothing to add to what Ralph reported.
- Mark – Spoke with Donna. Jerry is recovering from a leg injury.
- John – Spoke with Frannie today. Rayburn is doing well from his surgery. She has closed her clinic. They are excited to be getting new members.
- Laureen – No report; not at the meeting.
