Message from the Pastor

Dear Parishioners,

At the close of business on August 31, 2018, Operating Income vs. Expenses yielded a surplus of \$12,978.46. As you will see inside this report, last year our operating costs were almost \$430,000. While I am pleased to report a surplus, and our buildings are in good shape, the finance committee and I will continue to monitor our financial future carefully. Last year we did not achieve our budgeted goals for income, as we were about \$30,000 short of what we hoped we could achieve. Over the last fiscal year we continued to improve and maintain our buildings with a fresh coat of paint, and the purchase of a used baby grand piano for our music program. These improvements cost \$43,093.62 and were paid for using our operating surplus and parish savings.

In this report we have also included a report on our Haiti Fund which supports the Foyer St. Etienne in Les Cayes, Haiti. Our Haiti mission continues to be a beacon of hope and goodness for us as we reach out most generously to the poorest of the poor.
