Gifts of stock may be made via electronic transfer. The Diocese of Houma-Thibodaux maintains a brokerage account with Edward Jones Investments for the purpose of processing stock transfers to the diocese for benefit of the Diocese of Houma-Thibodaux or any of its parishes, schools, or agencies. <u>The diocese cannot initiate stock transfers on your behalf.</u> You must contact your broker directly.

If securities are electronically transferred, the gift date is the date securities enter our account at Edward Jones Investments. For hand-delivered securities to the Diocese Edward Jones Investments, the gift date is the date received. If the securities are mailed to the Diocese, the gift date is the date of the mailing (recommended sending by registered mail). Stock market fluctuations after the date of delivery (as defined above) will not affect the charitable deduction for tax purposes.

Edward Jones Investments has instructions to sell stock as soon as possible (usually by the business day following their receipt of stock). The actual net proceeds from the sale represent the amount that will be applied as you requested above. The new proceeds will be affected by the actual sale price, as well as broker charge to process the transaction. Accordingly, there will be variance between the charitable deduction amount and the net proceeds from the gift. The Diocese cannot be responsible for any variance in these amounts.
