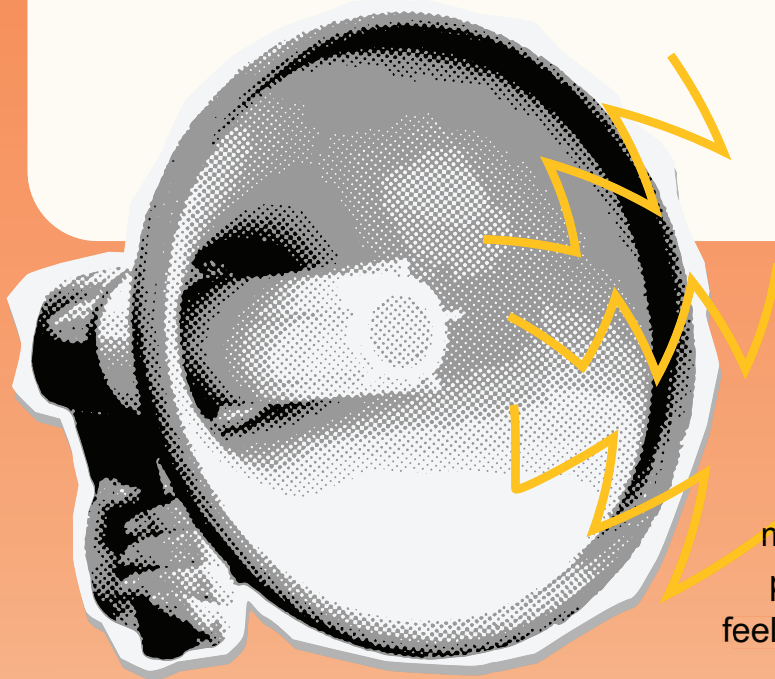

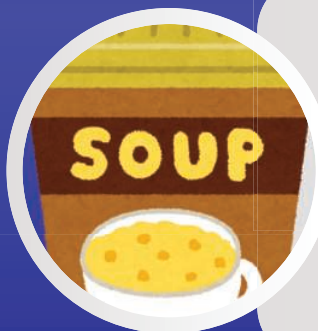
MINISTRY HIGHLIGHTS
