Parkes, Bishop of the Diocese of St. Petersburg, a Corporation Sole, from and against any and all loss, claims, expenses and attorney fees and to accept all liability arising out of or resulting from any possible injuries occurring to person on the leased premises and any or all damage to, loss or destruction of property, including the loss of use thereof. The word "property" as used herein shall be construed to include the building, its contents and equipment, whether owned by the Diocese of St. Petersburg or others.

## Rules of Tomahawk Lodge

1. Whatever you bring to Tomahawk Lodge, take with you when you leave. That includes trash, used items, discarded floatation devices, etc. A dumpster would ruin the beauty and add money to the cost.
2. We hope that you found the Lodge in good shape. If those before you did not leave it clean, please leave it cleaner than they did and let us know about any problems.
3. Our fireplace is ornamental; DO NOT BURN anything in the fireplace.
4. Outdoor fires can be built only in the fire ring provided - nowhere else on property. Please burn safely and be sure that the fire is completely out before you leave (*douse with water until no smoke is seen*).
5. Rope swings, while great fun, are a terrible liability. Please do not let your stay here be marred by injury. NO ROPE SWINGS. Installing a rope swing will disallow your return.
6. Please respect property boundaries; remember peace & quiet, speed limits and respect our neighbors and all wildlife.
7. Do not remove any post or other barriers or markers on the property. They are there for a reason and should be left alone.
8. If you must move beds or other furniture, please lift and move instead of scraping across the floor and return what you have moved to where you found it.
9. All water activities must be supervised and that is your responsibility. Use the river and all facilities at your own risk. Please be safe!

*The next three rules (Laws) are enforced by the Marion County Sheriff's Department.*

10. All containers taken on the river must be reusable. A soda can will warrant a fine. All consumables must be reusable containers. No exceptions.
11. All canoe or kayak users must have a life jacket and each boat must have at least one whistle. There should be no more than three (3) people in a canoe at one time.
12. Snorkelers must display a dive flag

## Arrival Procedures

1. The front gate is located at the end of 190th Ave, just off of Hwy 484 in Dunnellon. The codes to enter the property will be provided to you a week before your scheduled arrival. There is a combination lock on the front gate and a lock box next to the front door.
2. Turn on the hot water heater and well pump by the switches located in the kitchen.
3. The key for the canoes (on a tag shaped like a canoe) is kept in the closet next to the downstairs bathroom.
4. If you notice problems with the way the previous group left things, send a text to the Facility Manager.
5. Open doors as you please and make yourselves at home.

## Departure Procedures

### **Kitchen**

1. Make sure that the stove and microwave are clean and off. Unplug the microwave.
2. Empty and clean both the refrigerator and the freezer.
3. Please do not leave any food and take all of your trash with you.
4. Wipe clean the tables, stove and countertops, then sweep the floor.
5. Make sure that all dishes, pots and other kitchen implements are clean and put away.

### **Bathrooms**

1. Take all of your soaps and other hygiene products with you.
2. Sweep the floors and take the trash with you.
3. Rinse the sinks and shower. Please also flush the toilets.

### **General**

1. Turn off the water heater and well pump (switches are in the kitchen).
2. Please return all beds (and other furniture) to the same place that you found them.
3. Sweep floors upstairs and vacuum downstairs.
4. Remove all of your trash from the property.
5. Lock the canoe to the rack and make sure that all of the water equipment is dry and returned to the closet along with the key.
6. Be sure to close, latch and lock all windows and doors.
7. Be sure to turn off all lights and fans.
8. Be sure to lock the front gate when you leave.
