Roles & Service

- Spiritual Director & Clergy advisor
- Coordinator: Chairs monthly team meetings & communicates w/ parish office & staff
- Co-Coordinator: Supports Coordinator & team
- Treasure: Manages funds to support needs/ works with parish book keeper
- Assessment Leaders: Contacts person in need & assesses support needed.
- Secretary: Manages notes from meetings & reports
- Records Keeper: Manages records of support & mandatory documentation / works with parish office staff
- Resource Contact: Keeps up to date information on local, diocesan, state and federal programs of support.
- Prayer Companion: Personal contact & follow up by phone or in person.
- Church Contact Leader: To implement the team necessary at their location to accomplish support or unity with additional teams.
- Church Team: Follow through on support in a manageable and reasonable time frame / communicating with Church Contact Leader.

The Grace & Action Ministry Team meets monthly and the current 'board' and its members are voted in and each serve a term of two years.
