<u>Mass Times Survey</u> The survey I conducted at Holy Mass last weekend yielded the following results:

- 1. 8:00 a.m. at St. Mary's and 10:30 a.m. at St. Joseph's (St. Mary's—28; St. Joseph's—21).
- 2. 8:30 a.m. at St. Mary's and 11:00 a.m. at St. Joseph's (St. Mary's—80; St. Joseph's—2).
- 3. 8:15 a.m. at St. Mary's and 10:45 a.m. at St. Joseph's (St. Mary's—10; St. Joseph's—0).

Where does this leave us? It mainly gives evidence that people like the Mass times the way they are scheduled right now. I don't blame anyone for that response, in other words, of keeping things the same as all are accustomed to. But I do hope that people can see my desire to be watchful of my health, and my desire to form the prayerful atmosphere for Holy Mass to which I feel called. I know I cannot satisfy all preferences, but I was very curious as to your responses to this survey. I will have the surveys available this weekend for anyone who missed out on their chance last weekend. It may be that I sit down with the two trustees of each parish, all together, and have them help form my decision. I will make the best decision that I can, and I thank you for your patience.

Church Calendars for 2019 [re-printed] changed the front wording of church 2019 calendars to reflect our Catholic mission here in Hamilton County. While we may have a narrow section of parish boundary that edges into York and Clay Counties, the vast majority of parishioners are Hamilton County residents; this binds our two parishes together as the Catholic presence for all who live here. *** One interesting thing to note in the calendar is that each Friday of the year is shown to be a day of fasting. This provision is something I have found to be not well known about, even among Catholics who go to Mass every Sunday. *** The web link below has stringent copyright restrictions, such that I feel only that I can give the link to it. It is a document issued on November 18, 1966, by the United States bishops about fasting laws within the Church in our nation. I encourage you to read it and to be informed on why we fast, and when we are to fast. I hope to preach on this topic, as a good share of the responsibility for the faithful in the pews to know about fasting rests upon their shepherds. *** It is important to note that one should not say to oneself, "Don't tell me about this, I'd rather not know." To which I would respond that the Church given us by Jesus Christ works in the world of today for the main goal of helping us to spend all of eternity with our Savior. And the more we know about how to live in such a way now so as to live with our Savior forever, the better and easier will life be for us on "this side of the veil", i.e. on this side of eternal life. *** Bottom line: we cannot do enough to voluntarily fast and make amendment for our sinfulness.
