2) Review Comal County Tax Office's tax calculations and develop a proposed tax rate for 2019, - All Commissioners;

The Comal County Tax Office tax calculations were reviewed. The options to use last years tax rate of \$0.085100/\$100, this year's effective tax rate of \$0.7859000/\$100, the rollback tax rate of \$0.092145/\$100 and several other options were discussed in detail including advantages and disadvantages. Consideration was given to 18% increase in the Service Providers 2020 budget, the need to move forward new ambulance purchases and fact that there are no longer any savings in buying a new ambulance chassis and reinstalling the box. Based on a consensus the proposed rate for 2019 of \$0.09000/\$100 was selected. Bill Gonser made the following motion which was seconded by Brad McMinn. ESD #1 proposes a tax rate of \$0.09000/\$100 for 2019. A roll call vote was call. Pat Feely YES, Brad McMinn YES, Tex Hall YES and Bill Gonser YES. Mark Schmalz could not vote. The motion passed.

3) Set date and time for the 1st Public Hearing, - All Commissioners;

The first Public Hearing is scheduled for August 21 and the second Public Hearing is scheduled for August 28.

The meeting was adjourned at 4:53 PM.
