COMAL COUNTY EMERGENCY SERVICES DISTRICT NO. 4 Minutes for March 2, 2021 Meeting

The Board of Commissioners of Comal County Emergency Services District No. 4 was held on Tuesday, March 2, 2021, at 5:30 PM. This meeting was conducted as a combination of in person and remote access in order to allow compliance with appropriate social distancing and mass gathering precautions for the purposes listed below.
