## **DISCUSSION / ACTION ITEMS**

- 1) Call meeting to order, prayer; Public Comments: Members of the public may collectively address the Board for a total of thirty minutes on items not on the current agenda (i.e. the public comment section of the meeting). Individual members of the public may address the Board for a maximum of three minutes on items not on the current agenda (i.e. the public comment section of the meeting). Individual members of the public may address the Board for a maximum of three minutes per person per agenda item. Individuals may address the Board once per item. Members of the public may collectively address the Board for a total of thirty minutes per item on the agenda. Members of the public will speak on an agenda item after comments on the item is called for by the presiding officer, but before Board discussion and consideration of the item. Speakers will be called upon in the order that they signed up to speak on an item. If more than ten speakers sign up to speak on an agenda item or as part of public comment on items not on the agenda item, each speaker's allotted time will be proportionally reduced to allow all speakers an opportunity to speak within the 30-minute time limit.
- 2) Discuss Property at 27450 State Hwy 46, for future station, containing partials being offered by Kenny Manhoff, Owner, described in a contract prepared by Rex Blackburn of The Blackburn Group/ Blue Collar Commercial Group, with certain terms and intent to enter into further negotiations towards acquiring property described in said contract and its boundaries. Establish an Option Period, discuss and put to vote the acceptance of Earnest Money Deposit, understand that feasibility studies may proceed within Option Period.

Board is asked to consider and vote upon presenting this contract as part of negotiations with Seller. Along with associated fees for services in gathering survey and feasibility data, towards possible purchase; complementing our letter of intent previously approved.

Allowing our actions to be a clear and concise approach in stewarding the finances and mission of the Bulverde/Spring Branch Emergency Services District 1, on behalf of the community of Western Comal County.
