
1. Call to Order.

In reliance upon the guidance provided by the Office of the Attorney General of Texas Open Meetings Handbook, any issues raised in public comment may be responded to by member of the Board of Commissioners with only (1) a statement of specific factual information, (2) a recitation of existing District policy or (3) a brief deliberation by the Board in order to determine if an item should be placed on a subsequent agenda.
4. Consider approval of the minutes from 22 June 2022 Regular Meeting and 21 July Special Meeting.
5. Consider, discuss, and act on the monthly financial reports for June, individual financial transactions, and payment of bills/invoices.
6. Receive monthly report from BSBES Chief regarding emergency operations, response times, call volume, training, management activities and personnel.
7. Consider, discuss, and act on the 2023 proposed Budget.
8. Consider, discuss and act on next steps in Truth in Taxation process (date to review tax rate calculations, proposed tax rate, public hearing date, tax rate adoption date, etc.).
9. Consider, discuss, and act on feasibility study for ESD 1 land as possible site for Station 5.
10. Consider, discuss, and act on any items related to the future Station 5.
11. Receive reports on the BSBES board meeting and any joint committee meetings that occurred.
