DISCUSSION / ACTION ITEMS

- 1) Meeting called to order at 3:02 pm, establishing a Quorum of Dan Saenz, Henry Delgado and Josh Dean. No Public Comments: Members of the public may collectively address the Board for a total of thirty minutes on items not on the current agenda (i.e. the public comment section of the meeting). Individual members of the public may address the Board for a maximum of three minutes on items not on the current agenda (i.e. the public comment section of the meeting). Individual members of the public may address the Board for a maximum of three minutes per person per agenda item. Individuals may address the Board once per item. Members of the public may collectively address the Board for a total of thirty minutes per item on the agenda. Members of the public will speak on an agenda item after comments on the item is called for by the presiding officer, but before Board discussion and consideration of the item. Speakers will be called upon in the order that they signed up to speak on an item. If more than ten speakers sign up to speak on an agenda item or as part of public comment on items not on the agenda item, each speaker's allotted time will be proportionally reduced to allow all speakers an opportunity to speak within the 30-minute time limit.

- 3) Approve May 23, 2023 Meeting minutes. Henry Delgado made a motion to approve minutes, Josh Dean seconded passed unanimously

- 10) Discuss and take action on matters regarding rental property as needed; Repairs, release of a deposit and upcoming vacancy.—Josh Dean made a motion to not rent out any of the existing rental houses on the Temp 5 property or any that become available and to repay the deposits on vacated rentals that were maintained. Dan Saenz seconded passed unanimously.

 Discuss Ink Civil updates on Replat and Site Plan information, INK Civil is waiting on ESD 1 to locate a water well service. Review and approve water well estimate, No action taken. No well estimate provided.
