NOTICE was given that a Special Meeting of the Board of Commissioners of Comal County Emergency Services District No. 1 was held Wednesday, August 9, 2023 beginning at 5pm; at Station 1 located at 353 Rodeo Dr, Spring Branch, TX 78070 for the following purposes.

DISCUSSION / ACTION ITEMS

- 1) Call meeting to order at 5:14 PM President Dan Saenz, Treasure Henry Delgado and Secretary Josh Dean were present, prayer; Public Comments: Members of the public may collectively address the Board for a total of thirty minutes on items not on the current agenda (i.e. the public comment section of the meeting). Individual members of the public may address the Board for a maximum of three minutes on items not on the current agenda (i.e. the public comment section of the meeting). Individual members of the public may address the Board for a maximum of three minutes per person per agenda item. Individuals may address the Board once per item. Members of the public may collectively address the Board for a total of thirty minutes per item on the agenda. Members of the public will speak on an agenda item after comments on the item is called for by the presiding officer, but before Board discussion and consideration of the item. Speakers will be called upon in the order that they signed up to speak on an item. If more than ten speakers sign up to speak on an agenda item or as part of public comment on items not on the agenda item, each speaker's allotted time will be proportionally reduced to allow all speakers an opportunity to speak within the 30-minute time limit. No public in attendance.
- 2) Discuss and present for vote, the acceptance of the 2024 Budget. All Commissioners. No action taken.
- 3) Review and discuss available 2024 Tax Rates presented by Comal County, followed by selecting appropriate Tax Rate and present to vote. Josh Dean made a motion to adopt a tax rate of \$0.069826 for 2024 down from the tax rate of \$0.070796 for 2023. Seconded by Dan Saenz. Passed unanimously.
- 4) Executive Session, to discuss and consider employee, operations, real estate, and legal matters. No Executive session
- 5) Adjourn Special Meeting at 6:14 PM. Next meeting will be August 21, 2023, at 5:00 PM.
