- 6. To adopt the District 2025 Ad Valorem Tax Rate For Debt Service
 - > There is no debt so there is no debt tax rate to be adopted
- 7. To adopt the District 2025 total Ad Valorem Tax Rate
 - > Since there was no debt service rate this rate is set by the motion in item 5 above at 0.072471.
